## **Export Regulations:**

Export of Thermal Imaging Cameras with the image refresh rate over 9Hz (including user manuals) are controlled by the U.S. Department of State Directorate of Defense Trade Controls, in accordance with the International Traffic in Arms Regulations (ITAR), Title 22, Code of Federal Regulations Part 120-130 and/or the U.S. Department of Commerce Bureau of Industry and Security in accordance with the Export Administration Regulations (EAR), Title 15, Code of Federal Regulations Part 730. Some of this equipment may require a license for export or reexport from the United States. Any export of equipment by Flir to a purchaser outside of the United States will be made in strict compliance with U.S. export control laws; diversion contrary to U.S. law is prohibited.

It is the purchaser's responsibility to request and obtain any required export licenses for the subsequent export or reexport of the subject item, and to ensure that the requirements of all applicable laws, regulations and administrative policies are met.
